

Iron Sight K-9 Training Agreement

This training agreement is between Iron-Sight K-9, hereafter "kennel" and the pet owner.

Kennel agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly maintained. The pet(s) is (are) to be fed properly and regularly, and to be housed in safe quarters.

Owner specifically represents that the pet has not contracted, nor been exposed to any contagious diseases, to include: rabies, distemper, parvovirus, and/or Bordetella within a thirty-day period prior to arriving at the kennel's facility.

All pets are boarded or are otherwise handled or cared for by the kennel without liability on the kennel's part for loss or damage from disease, natural disaster, theft, fire, death, escape, injury, or harm to persons, or for other unavoidable causes, due diligence and care having been exercised.

Obedience training will cover **on-leash (basic)** or **off-leash (advanced)** (please circle) commands to sit, down, stay, place, heel, come, off, and leave it. Problem behaviors such as jumping up, mouthing/biting, and greeting people will also be addressed. **Owner understands that their participation in follow-up lessons, included in the training fee, is essential to ensuring successful maintenance of the obedience training and behavior problem management.** Owner also understands that Iron-Sight K-9 will provide these follow-up lessons as needed at the mutual convenience of the Kennel and owner.

Iron-Sight K-9 agrees to provide satisfactory training to its customers and promises a one (1) year guarantee to its clients. If after the in-board training is complete, and the owner has attended a minimum two (2) private lessons, the kennel agrees to provide one week of additional remedial in-board training at no extra charge, and will provide two (2) in-home private follow-up lessons.

Owner agrees to pay Iron-Sight K-9 _____ per pet for such training. A portion of the fee will be collected upon drop-off of the pet(s) and the balance will be due at the time of pick-up of pet(s). Any miscellaneous charges for services desired by owner will be due upon pick-up as well. Owner further agrees that pet(s) shall not leave the kennel until all charges are paid to the kennel by owner. Kennel shall have and is hereby granted a lien on the pet(s) for any and all unpaid charges resulting from training pet(s) at kennel.

If, in the opinion of the Kennel, the pet(s) must stay beyond the agreed pick-up date to complete all training requirements to the satisfaction of the Master Trainer, kennel agrees to provide all necessary additional training and boarding at no extra cost. If the pet(s) become ill, or if the state of the pet(s) health otherwise requires professional attention, Kennel, in its sole discretion may engage the services of a veterinarian of its choosing, or administer medicine, or provide other required attention to the animal at the expenses of the owner.

It is understood by kennel and owner that all provisions of this agreement shall be binding upon both parties thereunto for this visit and for all subsequent visits.
